

PRIVACY POLICY FOR FORFAITING SOLUTIONS DAC

1 General information on data processing

Forfaiting Solutions dac is taking data protection very seriously. For this reason we ask you to read the following Privacy Policy carefully. We regularly take precautions and adapt our security measures to the latest legal and technical changes.

In accordance with the General Data Protection Regulation (GDPR) we have taken technical and organisational arrangements for treating your personal data confidential. We expressly point out that the transfer of data on the internet (for example by email) may have security vulnerabilities. A complete protection of data from access by third parties cannot be guaranteed. We cannot assume any liability for any damage caused by such security gaps.

2 Scope

We process and store personal data you are sending us online (email, etc.) or offline (by post, etc.). The use of our website is possible without providing personal data. This Privacy Policy applies to all personal data we collect.

3 Data collection

3.1 contacting us

If you contact us via email or via other communication means your data (e.g. name, address, contact information) will be used for preparing and providing our response to you, or for contract fulfilment as well as for the necessary technical administration.

3.2 data logging

When visiting our website information about the access (IP address, date, time, page visited) is stored automatically on the server. Such information is collected for statistical evaluation and monitoring.

3.3 Cookies

Our website uses so-called cookies. These are small text documents that are stored on your hard drive. Through these cookies we get automatically certain data e.g. IP address, browser type, operating system of your computer and your internet access. Through the information acquired through these cookies we can help in the navigation of our website and enable the correct display of our website. You can deactivate the cookies via your browser any time and by doing this decline the use of cookies from our website. We point out that in such case some functions of our website might not work correctly. Otherwise you agree with the use of cookies and the data acquired in this process.

4 Storage period for your data

The stored personal data that you provide to us will be kept by us only as long as needed for the fulfilment of the purpose of the data transfer or as long as required by law.

5 Data transfer

Data will only be passed on to third parties (e.g. banks, involved contract and business partners, auditors, IT service providers, legal representatives, courts when needed, etc.) if this is necessary for the fulfilment of legal obligations or for a contractual relationship.

6 Confidentiality

Our personnel are obliged to keep data confidential according to the General Data Protection Regulation as amended from time to time.

7 Your rights

You have the right for information, correction, deletion, restriction, data portability and revocation related to your personal data for the future. If you believe that the processing of your data violates the GDPR or if your data protection rights have otherwise been violated, you can complain to the supervisory authority.
